

# COLUMBIA FALLS CROSS COUNTRY CRUISE 2012

A 6-kilometer (3.6-mile) Fun Run

Saturday July 21, 2012 – 9:00am

All proceeds benefit the Columbia Falls High School Cross Country Program. The course winds through neighborhoods near the high school, with cross country jaunts through two city parks. Prizes in the form of gift certificates will be awarded to the top overall, youth (under 16), and master (40+) runners by gender.

**Entry Fee:** \$15 per person and \$40 per family of four (\$6/person for additional children) postmarked on or before July 16, 2012. Day-of-race registration is \$20 per person and \$45 per family of four.
